1. The National Organization, SUVCW has issued a new revised version of Form 27, Camp Annual Report. The new form is Form 27a, Camp Annual Report and it is available on the National SUVCW Website at: <http://suvchw.org/ftp.htm> . Please be sure to use this new version as all previous versions are now void.
2. A reminder to all camp Commanders and Secretaries that Form 27a Camp Annual Report is due to the Department Secretary by April 30, 2008. This is a firm deadline and there are no acceptable excuses for not having Form 27a in on time. Commander-in-Chief Kuhn has made it clear that any Department that fails to submit its' Annual Report on time will face disciplinary action. The only way that this Department can submit its' Annual Report on time and avoid disciplinary action is to have ALL properly completed Camp Annual Reports in on time. Therefore, any Camp that does not have their Form 27a in by April 30, 2008 will be suspended on May 1, 2008. I strongly encourage ALL Camps to submit their Form 27a prior to the April 30th deadline.

Department Treasurers Report

Treasury Notes – For all camp treasurers who have been worried that you must file an IRS form for your camp for the first time, I'm honored to be able to report that what is required is a short, simple process that, when you've done it, will satisfy the IRS, make your commander grin and impress all the ladies. Well, ok, I won't promise that it will impress the ladies. You need to go to <http://epostcard.form990.org/> use your camp EIN as an identifier and create a password. As with all things READ THE INSTRUCTIONS FIRST (<http://epostcard.form990.org/Files/ePostcardQuickStartGuide.pdf>). You will be provided a confirmation of your registration and a link to the postcard itself. Once there, just check a box attesting that your camp earned less than \$25,000 during 2007 and complete the organization information. If you have any question about your camp EIN number, both Commander Derr and I have a listing of Michigan Department camp numbers. I filed for both camp and department using my address as the organization's mailing address and the commander as Principle Officer using his address. These seem to have been accepted by the IRS.

A word of caution: Brother Dick Williams, of whose expertise I think a great deal, had some difficulty filing for another organization that had filed in the past. So we may have more difficulty changing addresses and officers in years to come. But it appears that new filers may use the addresses that they wish.

You will need to use one of the supported browsers. They are:

Microsoft Internet Explorer (v5.5 or newer)

- Firefox (v1.0 or newer)
- Netscape (v6.2 or newer)
- For MAC machines the only browser supported is Firefox.

If you have something other than these on your machine, plan to visit a friend who does use one of these and file from their computer.

General e-Postcard requirements, from the web site:

- a) Your organization must already be recognized as an exempt organization by the IRS.
- b) Your e-Postcard must be for tax year 2007 (or later).
- c) Your e-Postcard cannot be an amended e-Postcard.
- d) Your e-Postcard must be for a full 1 year period (no short period filings).
- e) Your organization must not be a private foundation.
- f) Your organization must normally have gross receipts of \$25,000 or less.

I accomplished our filing in a matter of fifteen minutes and the site provided a reply that the IRS had accepted the filing about a half hour after I had filed. Go for it, Brothers. It will be pleasing to get that task off your "to do" list.

In January, over 30 Brothers (and a large contingent of the Frances Finch Auxiliary) warmly welcomed Dept. Commander Dennis Derr II and Rick Greene PCC. Commander Derr conducted the installation of the 2008 Camp officers. DC Derr and PDC Greene were entertained the next hour by Camp 14's Brothers describing the many community projects we are involved with.

The Camp 14 audit was conducted by Brothers Jan White, Dan Bennett and Skillman. The Council informed the Camp that the books were in order and the new budget ratified. Compliments went to Brother Breaugh for his fine work balancing the books. He will 'juggle' the combined secretary and treasurer duties for another year. Dan informed me that Brother Tyler Putnam is producing Federal Type 1-2 Forage caps and are being offered for sale through Wambaugh, White and Co. Dan has very impressed with Tyler's exacting eye for detail and expert craftsmanship; high praise indeed. Tyler has completed a second season excavating the Johnson's Island POW (CSA) camp.

Our poet-laurete, Jim Ribby, will be reading a poem entitled "The Last Camp" written by James Wesley Benedict between 1872 (first 9 stanzas) and 1894 (4 stanzas). Mr. Benedict's granddaughter, Marjorie Schultz, will be traveling to Traverse City to hear Brother Ribby's performance. She has submitted the original poem to the Smithsonian Museum, where it is undergoing review to become part of that institution's collection.

On February 1st, Brothers Breaugh and Knoodle braved a winter storm to meet with Parks and Recreation superintendent, Al Hanson, to discuss the return of the Augusta Arsenal (CSA) cannon to Petoskey. In the Fall Messenger it was mentioned that there was a resolution in the Michigan State Senate that would change the statue of Senator Zachariah Chandler with a statue of President Gerald R. Ford in the National Statuary Hall, in Washington DC. The resolution was Senate Resolution 131 and was adopted by the Senate on December 12, 2007. A similar House Resolution (HR 148) was adopted June 28, 2007.

All that needs to be done to complete this action is for Gov. Jennifer Granholm to pass the Michigan Legislature's wishes to Congress, along with a letter supporting it, which she said she will do.

So, it is a given that Chandler will be packed in a crate and sent away after 96 years as one of Michigan's two most important people.

It is alarming when we forget about the people that shaped this country in its infancy; they are no less important and much easier to be unknown to our future generations than our 20th century heroes. I think its sad more folks refuse to care or realize that. On at least, his statue won't be destroyed. It is to be

(The following is an email from my nephew who is in Iraq on his second tour. He is with a Civil Affairs Battalion, (A Co. 415th CA BN).

All:

The dust is starting to settle and we are getting into the swing of things. I forgot how much I hated walking in this "moon dust". It's similar to walking in mud. I have my Soldiers spread all over the countryside. I only have 9 of the 30 with me at Kalsu. I got out to see some of my Soldiers today. It was nice to get out of the office for half a day. The roads are quite different from what they were last time I was here. They have Iraqi police and "Soldiers of Iraq" checkpoints all over the place. The "Soldiers of Iraq" are like community watch groups. Unfortunately they won't be getting paid in a few months which could lead to problems. They are the main ones that we are trying to find jobs for. Currently I live in a tent. I'll be moving into a room with 3 other Soldiers in the near future. I'm working on getting better arrangements for everyone. It won't be bad being 4 in a room, but I'm sure that I can find better.

Our major thrust here is to establish, improve businesses to get Iraqi's working. They have a 95% unemployment rate here. If we get them working, they will be less likely to help out the bad guys. It's kind of ironic that there is a Pepsi plant near our area. I'm not sure what they are trying to do for it. I set up lots of MicroGrants (>\$2500) to help out business people. There are several projects in the works. If Pepsi needs help, which I doubt, I won't be dealing with it since they will probably need more money than I deal with.

Well that's a quick snapshot of what I'm currently doing.(Please remember to keep our troops in your prayers!)

The meeting was followed on January 17 by a trip to the John Dingell Veterans Administration Hospital in Detroit, where camp members completed a six month effort of collecting money and materials for use by the Veterans. We spent time visiting, and found the experience very rewarding and appropriate for our vow to "remember all veterans". We have welcomed seven new Members since January 1st they are: Jason and Jeffrey Fite, Bill Hanusik, Martin A. P. Treppa, Dale Worcester, Henry Heatley, and Christopher J. Yagley. Upcoming months will find us providing an honor guard for a Dearborn Library "Abraham Lincoln" speaker, dedicating a headstone for a Member's ancestor at Woodmere Cemetery, and Marching in the Dearborn Memorial Day Parade.

Considering the season, this is always worth retelling: In the heyday of the sailing ship, every ship had to have cannon for protection. Cannon of the times required round iron cannon balls. The master wanted to store the cannon balls so they would be of instant use when needed, but not roll around the gun deck. The solution was to stack them in a square based pyramid next to the cannon. The top level had one ball, the next level down had four balls, the next had nine, the next sixteen, and so on. Four levels would provide a stack of 30 cannon balls. The only real problem was how to keep the bottom level from sliding out under the weight of the higher levels. To remedy this, a small plate called a "monkey" - with one rounded indentation for each bottom later cannon ball was used. When iron was used to make the plate, the cannonballs would rust to the plate. As a result, these plates were made of brass, thus the name "brass monkey". When temperatures fall, brass contracts faster than iron. As it got colder on the gun decks, the brass plates would get smaller, and spill the cannon balls over the deck. Thus, it was quite literal "COLD ENOUGH TO FREEZE THE BALLS OFF OF A BRASS MONKEY!"

1st Michigan Volunteer Infantry Regiment (3 Year Enlistment).

The 1st Michigan Infantry was organized at Detroit, Michigan and mustered into Federal service for a three year enlistment on September 16, 1861. This regiment retained a number of the original 1st Michigan raised for a three month enlistment, particularly the officers. The regiment was mustered out on July 19, 1865. The regiment was given to Captain John C. Robinson of the US Army, who was made Colonel of Volunteers.

The 3 month Regiment returned to Michigan and was mustered out of Federal service on Aug.7,1861. Then the Regiment was immediately reorganized into a three year term of enlistment at Ann Arbor and immediately, with 960 officers and men set out for Virginia on Sept.7,1861.

The Regiment took part in the Peninsular Campaign of 1862 under the command of General McClellan serving in the 5th. Corp, 1st. Brigade, 1st. Division. It fought gallantly at Mechanicsville, Gaine's Mill, Peach Orchard, Savage Station, Turkey Bend, White Oak Swamp and Malvern Hill. After the Peninsular Campaign it was assigned to Fitz John Porter's Corp when it was desperately engaged at Second Manassas (2nd. Bull Run) on Aug.19, 1862. It and the other Regiments of the Brigade sustained fearful losses from the murderous fire of the Confederates masked batteries.

The Regiment then took part in the battles of Antietam, Md. Fredricksburg, Va. and Chancellorsville, Va. before reaching Gettysburg, Pa. on July 2, 1863, in time to bear an active role in one of the hardest fought and most historic battles of the war, Colonel Troop's action report describes the part taken by the 1st near the base of Little Round Top in the battle, found at the end of this article.

It was then engaged in active duty, with frequent contacts with Confederate forces until Feb. of 1864, when its enlistment term expired. At that time 212 of its members re-enlisted and were furloughed for thirty days to visit their homes.

On April 10, 1864 the Regiment re-assembled at Beverly Ford, Va. and then took an active part of the Campaign of 1864 being engaged at Allsops Mill, Spottsylvania, The Nye River, The North Anna River, Jerico Mill and Tolopotomy. It crossed the James River on June 16, 1864 and arrived in front of Petersburg on the 18th., when it was engaged in a desperate encounter with Confederate forces at Poplar Grove Church. The Regiment was continually employed, either building fortifications or skirmishing with the Confederates until Feb. 05, 1865, when it started on the pursuit of Gen. Lee's retreating forces around Richmond, Va., marching and fighting until the surrender of the Army of Northern Virginia at Appomattox Court House. After the surrender the Regiment proceeded by rail to Louisville, Ky., where it was mustered out of Federal service on July 19th. They then returned to Jackson, Mi. arriving on July 22nd, ceremoniously paid off and disbanded.

Colonel Troop's Action Report, 1st Michigan Infantry at the Battle of Gettysburg From the Official Records

"We left Hanover on the evening of the first with the brigade marching to a place near the battlefield of the second during the night. On the morning of the second we were formed in line of battle in reserve where we remained until about four o'clock P.M., when we (with the brigade) were ordered to the front. We got into position in line about 4:30 P.M., with the 22d Massachusetts on our left and the One Hundred and Eighteenth Pennsylvania on our right.

"We had no sooner got our line fully established than the enemy drove in our skirmishers and appeared in force in the edge of wood on our front, within two hundred yards of our line. We ordered our men to fix bayonets and commenced firing on the enemy with a deadly effect, driving him back after a severe fire of half an hour. He however soon returned and was a second time driven back with great loss.

"Our men stood up bravely under the storm of bullets sent against them, loading and firing as coolly as though on drill. We entered the fight with three field, one staff, sixteen line officers, and one hundred and twenty-five muskets.

"Our color bearer, Sergeant Patrick Connors, was the first man wounded after the firing commenced. The colors were at once taken from the ground by Corporal John H. Harrington of Co. 'A', and gallantly borne through the battle.

"Col. Ira C. Abbott was wounded in the face early in the action, and carried to the rear. We maintained our line, repulsing and holding in check the enemy until 7:30 P.M., when we were ordered to fall back, which we did in good order, being relieved by a brigade of Pennsylvania Reserves.

"Men never behaved more gallantly than did the soldiers of the 1st Michigan in this battle, and it would be impossible to mention each case of individual gallantry and bravery when all did so well, but I would mention the name of Sergeant Joseph F. Bird of Company 'A', who particularly attracted my attention by his coolness, bravery, and admirable control of his men, and thoughtfulness as to his duties.

"Among the officers I can make no separate mention, where all excelled their former reputation, and won for themselves new and lasting honors.

"Our losses are one commissioned officer killed and six wounded, and eight missing. Of the steady, true, and galling fire of the one hundred and seventy-five muskets in the hands of Michigan First regiment the bodies of sixty-two dead rebels left on our front bear a fearful testimony".

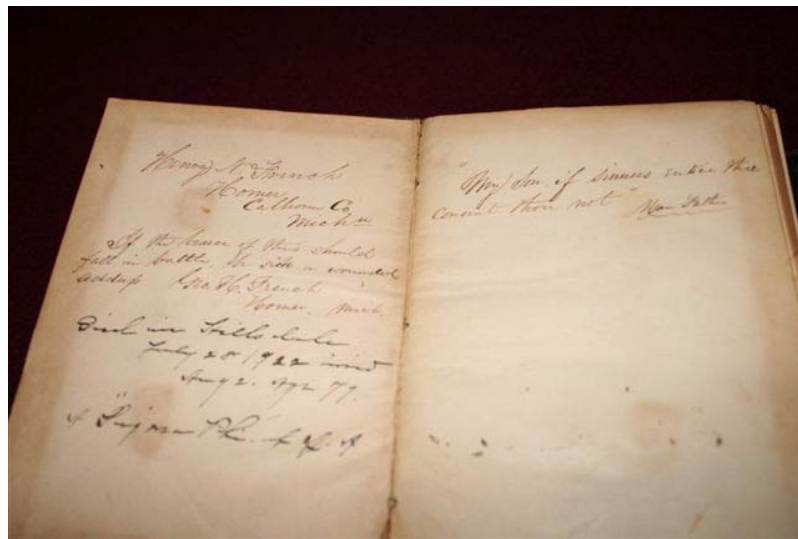

He is an avid collector of Civil War artifacts and history, but is not a member of the Sons. He expressed special interest in Co. M, 2nd Michigan Cavalry which seemed a bit strange.

After providing him packets of information on the Homer men in the unit, he revealed that he had a Bible that belonged to Henry French, a member of Co. M, 2nd MI Cavalry and Homer resident. Inside the back cover of the Bible was a pledge taken by those that left Homer together. The Bible was found at a Civil War relics show which explained his interest. Another unexpected piece of Homer memorabilia that surfaced through a chance reading of our publication.

A transcribed copy of the pledge found on the back page of the Bible follows:

We the undersigned being about to enter the army in defense of the Union, Government and Constitution of the United States do for the purpose of mutual support, protection and defense, while in the service, hereby make the following agreement with each other and pledge ourselves to its faithful observance. That we will aid assist and defend each other in the camp, on the battlefield, and in every emergence.

That we will abstain from the use of intoxicating drinks as a beverage and from gambling and profanity.

That we will discountenance in each other all conduct unbecoming to us as Soldiers and men.

That we will cheerfully receive advise or reproof from each other respecting our behavior and deportment - agreeing also to watch over and warn each other of misconduct in a spirit of kindness and mutual regard.

Subject: Ratification of Constitutional Amendments

To: SUVCW Department Secretaries

cc: SUVCW Department Commanders

At the Special National Encampment held on 17 November in Gettysburg, PA, the language for amendments to two sections of Article VII of our Constitution was approved. They are included in the attachments. These amendments relate to adding Juniors as a category of membership. As a result of actions taken at the 126th National Encampment in St. Louis, it was determined that the Constitution and Regulations were in conflict over Juniors. This prompted the call for a Special National Encampment in order to synchronize the Constitution and Regulations in a timely manner. Although the language was approved, these amendments do not become effective until they are ratified by 51% of the Departments in our Order. The Commander-in-Chief is requesting that a vote on these Constitutional amendments be added to your order of business for your 2008 Department Encampments. The following is the process you will need to follow:

- Distribute these Constitutional amendments to members in your Departments (either directly or through your Camp Secretaries) such that delegates have ample time to review them prior to your Department Encampment.
- Call for a vote at the Department Encampment - ratification requires only a simple majority of the delegates present at your Department Encampments.
- Indicate on the attached forms whether or not the Department ratified the amendments. The forms must be signed by the Department Commander and you, the Department Secretary.
- Mail the signed form immediately following your Department Encampment to the following address:

I must receive hardcopies of the ratification forms. Please do not send electronic versions.

In addition to the changes to the Constitution, there were a number of changes to the Regulations approved at the Special National Encampment. The changes to the Regulations become effective on 01 July 2008 only if the proposed changes to the Constitution survive the ratification process. In addition to this electronic mailing, I will also be sending hardcopies through regular mail to make sure all Department Secretaries receive at least one version of this request. For those that receive it, please consider this e-mail as official notification of action required by your Department. Please let me know if you have any questions or need clarification on any on the information presented. Thanks in advance for your attention to this matter.

THE TWO AMENDMENTS THAT WILL REQUIRE RATIFICATION ARE ON PAGES 16 AND 17

The Department of _____ with all of its Officers and Brothers seated there in on the _____ day of _____, 2008 met in annual Encampment and voted on the following amendment to the Constitution of the Sons of Union Veterans of the Civil War;

ARTICLE VII.
Membership

Section 1. Membership classes. There shall be ~~three (3)~~ **four (4)** classes of membership.

(a) Members. Males at least fourteen (14) years of age who meet the qualifications stipulated in Article III of this Constitution and *Section 200303 of the Articles of Incorporation as amended in 1998*. Members enjoy all the rights, privileges and responsibilities of membership.

(d) Junior Members. Males less than fourteen (14) years of age who meet the qualifications stipulated in Article III of this Constitution and Section 200303 of the Articles of Incorporation as amended in 1998. The minimum age for Junior Members shall be specified in the Regulations of the Order.

Section 4. A ~~Member~~ **Brother** in good standing upon written application to his Camp shall be entitled to receive a Transfer Card or ~~Honorable Discharge~~ **of the appropriate type** and, if his Camp be disbanded or suspended shall be entitled to receive a Transfer Card from the Commander of the Department.

Section 5. Restrictions on Junior Members and Junior Associates.

(a) Neither Junior Members nor Junior Associates may be elected to any National, Department or Camp office.

(b) The National Organization may further provide for the regulations of Junior Members and/or Junior Associates in the Regulations provided they are not inconsistent with the provisions of this section.

The Department of _____ with all of its Officers and Brothers seated there in on the _____ day of _____, 2008 met in annual Encampment and voted on the following amendment to the Constitution of the Sons of Union Veterans of the Civil War;

Section 2. Associates. There shall be ~~one~~ **two** classes of Associates.

(a) Associates are males at least fourteen (14) years of age who do not meet the qualifications stipulated in Article III of this Constitution and Section **5 200303** of the Articles of Incorporation **as amended in 1998** but otherwise meet the requirements for membership established by the National Organization.

(b) Junior Associates are males less than fourteen (14) years of age who do not meet the qualifications stipulated in Article III of this Constitution and Section 200303 of the Articles of Incorporation as amended in 1998 but otherwise meet the requirements for membership established by the National Organization. The minimum age for Junior Associates shall be specified in the Regulations of the Order.

(c) The **combined** number of Associates **and Junior Associates** in any Camp shall not exceed one-third (1/3) of the total roster of the Camp at the time of election. At no time during a meeting of a Camp, a Department, or the National Organization shall business be transacted if the number of Associates in attendance exceeds forty-nine per cent (49%) of the total attendance then present at said meeting.

(d) Associates may not be elected, appointed, or otherwise assume the offices of Commander-in-Chief, Senior Vice Commander-in-Chief, Junior Vice Commander-in-Chief, National Secretary, National Treasurer or be appointed Commanding Officer of the Sons of Veterans Reserve.

(e) Associates **and Junior Associates** shall not be counted toward the required number of members to establish a new Camp. The names of Associates **and Junior Associates** may not appear on the Camp Charter nor may Associates **or Junior Associates** be designated as Charter Members of the Camp. Associates otherwise enjoy all the rights, privileges, and responsibilities of membership

Section 3. Establishment of Associates **and Junior Associates** by Departments and Camps. Departments, at their own discretion, may establish Associates **and/or Junior Associates provided that no Department may establish Junior Associates without previously or concurrently establishing Associates**. Departments may impose further restrictions on Associates **and Junior Associates**, provided that the rights established in Chapter V, Article VI of the National Regulations may not be altered, reduced, or vacated. If a Department specifically establishes Associates **and/or Junior Associates** by amending its By-Laws, Camps within said Department may amend the Camp By-Laws and establish Associates **and/or Junior Associates provided that no Camp shall establish Junior Associates without previously or concurrently establishing Associates**. Camps may impose further restrictions in accordance with the provisions of the Department By-Laws and provided that the rights established in Chapter V, Article VI of the National Regulations may not be altered, reduced, or vacated. If a Department does not establish Associates **and/or Junior Associates**, Camps within the Department's jurisdiction may not establish Associates **and/or Junior Associates**.
