As you know, I will not be seeking another term as Department Commander. I would like to take this opportunity to thank all of you, for making me welcome during camp visits, ceremonies and events as well as officer installations during the past year. You have made it one of the most rewarding experiences of my life. It has indeed been an honor to represent you.

Music played an integral role in the Civil War. Bands performed during war rallies, they were used as a recruitment tool, and they helped inspire troops during battle engagements. The U. S. War Department officially sanctioned regimental brass bands in May 1861. By decree, each infantry or artillery regiment was permitted one 24 man band, and cavalry regiments were allowed a 16 man ensemble. However, in July of 1862, the U. S. Adjutant General ordered all volunteer regimental brass ensembles disbanded due to high maintenance costs.

So, instead of using my words...

"A rich man's war and a poor man's fight..."
Southern opposition slogan, in *The Civil War* by Shelby Foote

It is rather for us to be here dedicated to the great task remaining before us, that from these honored dead we take increased devotion to that cause for which they here gave the last full measure of devotion; that we here highly resolve that these dead shall not have died in vain; that this nation, under God, shall have a new birth of freedom, and that government of the people, by the people, for the people, shall not perish from the earth."

The first quarter of 2013 has been an extremely busy time for the Department of Michigan. Beginning in January, the process of Installation of Camp Officers began and has kept several Department officers, including the Department Senior Vice Commander busy with travel and installations.

In addition to the various installations, the DSVC attended a number of planning meetings, Memorial Services, and Camp visits representing the Department of Michigan in keeping green the memory of our Civil War ancestors.

Planning activities for the 124<sup>th</sup> Department of Michigan Encampment to be held on May 3<sup>rd</sup> and 4<sup>th</sup> 2013 are well underway. The next planning meeting will be March 16, 2013.

At the 124<sup>th</sup> Department Encampment, there will be two items concerning Bylaws. The Department will be asked to vote on these two items. The first item concerns the Department Bylaws with regard to the Lyon Camp of The Year Award. The creation of this award has been previously approved at an earlier Department Encampment. The vote required this year is in regard to the language required to amend the Bylaws to include this award.

The second item is for an amendment to language in the National Constitution and Regulations. At the 131st National Encampment of the Sons of Union Veterans meeting in Los Angeles on August 9-11, 2012, at which a quorum was present throughout, and the required majority of such delegates voted in favor to amend the preamble to the National Constitution of the Sons of Union Veterans of the Civil War as follows:

**From:** We, the descendants of soldiers, sailors, or marines who served in the Army or Navy of the United States of America during the War of the Rebellion of 1861 to 1865.

**To:** We, the descendants of soldiers, sailors, or marines who served in the Army, Navy, Marine Corps, or Revenue Cutter Service of the United States of America during the War of the Rebellion of 1861 to 1865.

This change is needed to recognize all the members of the United States Armed Forces that served in the American Civil War 1861-1865, as the membership requirements of the GAR and our organization, per Article III of the C&R, as the Marine Corps and Revenue Cutter Service were different branches of the Armed Forces.

As contained in Article IX of the Constitution, this amendment cannot be effected until favorably acted upon and ratified by at least by 50% of the Departments.

As required by the SUVCW Constitution, and directed by Commander-in-Chief Perley Mellor, in his General Order 04, Departments are directed to vote to approve, or disapprove, the proposed amendment during their 2013 Department Encampments, and report the results of that vote on this form.

During the Civil War, the value of a prisoner depended on his rank. In prisoner exchanges, a general was worth up to 60 privates, a major general was worth up to 46 privates, and so on. At the lower end of the exchange scale, a non-commissioned officer was worth two privates, and privates were traded one-for-one. Approximately 200,000 soldiers from both sides were freed through prisoner exchanges.

Captured soldiers were expected to "give parole" or promise not to escape. If parole was offered and accepted, soldiers would be sent back to their own lines under a flag of truce and be sent home until an exchange could be effected.

Camp Commanders, please distribute the following to all Brothers in your respective Camps.

Brothers of the Various Camps, Department of Michigan, Sons of Union Veterans of the Civil War:

At the **131**<sup>st</sup> **National Encampment** of the Sons of Union Veterans of the Civil War, held in Los Angeles, California on August 9-11, 2012, an amendment to the SUVCW Constitution was proposed. There being a quorum present throughout, and the majority of such delegates voted in favor to amend the preamble to the National Constitution of the Sons of Union Veterans of the Civil War as follows:

#### FROM:

We, the descendants of soldiers, sailors, or marines who served in the Army or Navy of the United States of America during the Rebellion of 1861 to 1865.

#### TO:

We, the descendants of soldiers, sailors, or marines who served in the Army, Navy or Marine Corps, or Revenue Cutter Service of the United States of America during the Rebellion of 1861 to 1865.

As prescribed in Article IX of the Constitution, this amendment cannot be effected until favorably acted upon and ratified by at least 50% of the Departments.

Therefore, per National General Order Number 04 you will be asked to vote to approve or disapprove the proposed amendment at the Department of Michigan Encampment to be held on May 4, 2013.

# SUPPLEMENTIAL REPORT DEPARTMENT BYLAWS COMMITTEE DEPARTMENT OF MICHIGAN SONS OF UNION VETERANS OF THE CIVIL WAR

At the 111<sup>th</sup> Encampment of the Department of Michigan, the brothers in Encampment assembled created the James T. Lyons Camp of the Year Award. It authorized the Department Commander to make the first such award in 2012 at the 112<sup>th</sup> Encampment of the Department of Michigan. The Encampment further empowered a Special Committee to develop objective criteria, so that the award would be awarded to the Camp that received the highest score, rather than at the subjective discretion of the Department Commander. The Encampment further instructed the permanent Department committee on Bylaws to propose such amendment to the Department Bylaws to make this award a permanent part of the award program of the Department. The following is the proposal of the Department Bylaws Committee. Article XVIII Awards and Insignia

#### Proposed Section 4.

**Section 4**. Authorization for a Department Camp of the Year award is provided. The award shall be known as the James T. Lyons Camp of the Year Award. The award shall be conferred by the Department Commander to the Camp considered to be the Camp of the Year, based upon an objective scoring procedure based upon various criteria to be adopted from time to time by a Special Department Committee and approved by a Department Encampment. Applications for the award shall be submitted on proper form to the Department Commander by March 15<sup>th</sup> of each year. The Recipient of the award shall be publicly announced and a certificate and/or other suitable award presented at the Annual Department of Michigan, SUVCW Encampment. Only one such award may be awarded in any one year.

## **15<sup>th</sup> Michigan Infantry** Submitted by James B. Pahl, PCinC

(This account is based upon and quotes frequently from "Michigan in the War" compiled by J. Robertson, Adjutant General.)

This regiment was organized in Monroe, Michigan under the direction of Colonel John M. Oliver. It was mustered into Federal service on March 20, 1862. It left camp on the 27<sup>th</sup> with 869 names on the rolls.

The regiment was assigned to serve with General Grant in Mississippi and arrived at Pittsburg Landing on April 5, 1862. The actions of the Battle of Shiloh over the next two days resulted in the loss of two officers and 31 men killed. one officer and 63 men wounded and 7 missing.

The regiment (as part of the 2<sup>nd</sup> brigade commanded by Colonel Oliver, as part of the 6<sup>th</sup> division (McArthur) helped form the outposts of the Union army in the attack on Corinth, Mississippi. The regiment lost an additional 13 killed, 32 wounded and five missing.

In November, the division moved from Corinth to Wolf Creek, serving as garrison and provost guard along with Memphis and Charleston railroad and scouting for querrillas. The regiment remained so engaged until June 5, 1863, when it was ordered to Vicksburg, Mississippi, assigned to the 1<sup>st</sup> division of the 9<sup>th</sup> corps. The Big Black river was crossed using rafts and swimming on June 6<sup>th</sup>, with the 15<sup>th</sup> leading the way. Arriving at the mouth of the Yazoo on June 11<sup>th</sup>, they boarded boats and disembarked at Hayne's Bluff. They participated on the advance on Jackson on July 4, then crossed the Big Black river again on the until arriving at Jackson. On the 23<sup>rd</sup> it began the march back to the Big Black.

The regiment was reassigned to the 2<sup>nd</sup> brigade, 4<sup>th</sup> division of 15<sup>th</sup> Army Corps., part of the Army of the Cumberland, and moved to Memphis, Tenn. on October 8, then onto Corinth on the 17<sup>th</sup>, then to luka and finally Florence, Alabama. The regiment remained quietly in Camp until becoming a veteran organization with 186 re-enlistments. The regiment left for Michigan on March 17, 1864, arriving on the 22<sup>nd</sup>, where they received a 30 day furlough. Once again rendezvousing at Monroe, they were back in Chattanooga, Tennessee on May 4.

The regiment took part in the Georgia campaign and participated in the engagements that occurred during the movement on Resaca. The regiment then took up entrenched positions near Dallas. Then moved to New Hope Church and then to Ackworth. On the 19<sup>th</sup> of June, the regiment moved to the right of the railroad facing Kennesaw Mountain, remaining until the 25<sup>th</sup>.

The regiment was engaged throughout, leading to the trenches before Atlanta and then in the engagements during the pursuit of the rebel army under Hood in Northern Georgia and Alabama. They moved back to Atlanta on November 12, 1864 then commenced the march with the army of General Sherman to Savannah, continuing without interruption until arriving at Clinton then moving onto Fort McAllister. They marched to Savannah and encamped there until January 14.

Embarking on transports, the regiment moved to Beaufort, S.C., arriving on the 15<sup>th</sup>. They then moved toward Raleigh and then finally began a line of march towards Richmond, VA, arriving there on May 6, 1865. They arrived in Washington, D.C. on the 21<sup>st</sup> and participated in the grand review of General Sherman's army on the 24<sup>th</sup>.

They remained until June 1, then boarding the cars of the Baltimore and Ohio railroad, moved to Louisville, KY and then transports to Little Rock, Arkansas, arriving there on July 7. They were stationed there until August 21, when the boarded transports for Cairo and then by rail to Michigan, arriving in Detroit on September 1, where they were paid off and discharged.

Total membership in the 15<sup>th</sup> was 2,371, losing 337, being 2 officers and 48 men killed in action, 1 officer and 18 men died of wounds; and 4 officers and 264 men dying of disease.

#### **Graves Registration Committee**

Your Department Graves Registration Committee met on March 9 at the State Archives. Attending that meeting were members Bill Lowe – At Large and Camp 7, Jim Jackson – Camp 22, Chris Czopek – At Large, Alan Teelander – At Large, Jim Harris – Camp 2, Dick Williams – Camp 58, Dick Hutchins – Camp 120, Chuck Worley – Camp 135, Gary Copenhaver – Camp 17, and myself for Camp 427. Our database now has 61,655 Civil War burials and 3,442 Other War records. We discussed the current VA direction on ordering headstones, and concurred that the ruling would probably not be rescinded, so now what?

We do not agree with the current guidelines, as it severely hampers our ability to "mark the graves" and "keep green the memory", but we must and will follow the law and our National Officer's directive. We decided that instead of being reactive, we would do two immediate things: 1) We will decide on a low-cost design (maybe home-made) for a "temporary marker" so that if we cannot find a descendent, we can manufacture and perhaps get a plastic attachment that states the man's name and regiment; and 2) at the suggestion of George Wilkinson, a 4<sup>th</sup> Michigan Infantry historian, we will partner with Alan Teelander, who has offered his Faded Footsteps site to list known burials of soldiers who do not have grave markers, and ask the public for a descendent to step forward aiding our task in marking the grave (we will also try and list these man on Find a Grave for the same purpose). If anyone has an idea about a "temporary grave marker" or resources for the same, let me know.

Irma saw our first robin of the year this morning. You know what that means, especially to those Camps who have never sent in any graves records and who have never attended a GRO Meeting (you know who you are), it means that you should get active and develop your Camp's plans to continue your work in the cemeteries in your areas.

It can be said that the first real battles of the Civil War occurred in 1856, when abolitionist John Brown, four of his sons, and two comrades brutally murdered five pro-slavery residents of the new state of Kansas. We say this because prior to 1854, the admitting of states to the Union was governed by the Missouri Compromise, which allowed one slave state for one free state, thus keeping the national government somewhat even in voting. The 1854 Kansas-Nebraska Act voided the previous act, and introduced "popular sovereignty" which decided if a state was to be free or slave based on the vote of the people. The slave owning states thought, rightly, that this was an attempt to tip the balance of government in favor of the free-staters.


