- 3. We would like to extend the appreciation and gratitude of the Department to all of the outgoing officers who served the Department so well and so faithfully over the last term. To Past Department Commander David Arnold, thank you for your service to the Department and the Order.
- 4. We offer the thanks of the Department to all those brothers filling elected and appointed offices for the 2013-2014 term as well as all of those who are currently serving the Order on committees.
- 5. The Department also extends our appreciation and gratitude to the Allied Orders including the Auxiliary To The Sons of Union Veterans of the Civil War and the Womens Relief Corps for their efforts in hosting the 124th Encampment of The Allied Orders. - 8. Memorial Day will be celebrated on Monday, May 27th this year. The actual date is May 30th. All Camps and all Brothers are encouraged to participate in some act of remembrance to mark this important day for Keeping Green The Memory. If you can do an activity with Brothers from your camp, so much the better. If you are unable to do something with your Camp Brothers, then consider a solo effort. Visit a cemetery and find the grave of a Civil War veteran, perhaps one that appears to have been forgotten. Make it your business honor him. Place a flag and flowers on the grave to honor that soldier. Memorial Day is a date central to our obligations as Sons of Union Veterans to keep green the memory of those soldiers and sailors of 1861 to 1865.

9. The National Encampment will be held this year in Brookfield/Milwaukee, Wisconsin. Site of the Encampment is the Sheraton Milwaukee Brookfield. Dates for the Encampment will be August 8th through 11th, 2013. Pre-registration materials are now available at http://2013.suvcw-wi.org/. The deadline for preregistration is July 31st 2013.

I regret to inform you of the death of three brothers in the Michigan SUVCW. They are:

**Charles T. "Chuck" Heffer** was a World War II veteran, who was born in Rochester, NY, on January 9, 1924. His Civil War ancestor was a great uncle who was killed at 2nd Bull Run. Brother Heffer died at Traverse City at the age of 89 years and has been creamated. There is no family to contact, so any condolences may be sent to Robert Finch Camp #14. I can find no obituary for Brother Heffer.

William P. "Bill" Watson II was a U.S. Army veteran, serving his country from 1959-1962. He was born in Dearborn, MI. on July 15, 1940. His Civil War ancestor was a Great-great Uncle, Private Lemuel F. Smith, Co. G, 3rd MI Inf., and Co. F, 5th MI, Inf.Brother Watson died in Traverse City, MI. at the age of 72 years, leaving behind his wife, Lynne, and three children; Scott,, Stephanie, and Michelle. James Richard (Rick) Greene, age 66 of Mayville, MI passed away Saturday, May 18, 2013 at home with his family. ## Guideline for Transport and Use of Department Flag Event/Battle Steamers

**Purpose:** The Department Event/Battle Streamers are irreplaceable. Consequently, the purpose of the guideline for use and transportation of the Department Event/Battle Streamers is to ensure that they continued to be displayed as much as possible, but at the same time reasonable care is taken ensured their maintenance for many years.

#### Procedure: Do Not:

- 1. Roll the battle streamers up into the flag
- 2. Wad up the battle streamers
- 3. Fold the battle streamers
- 4. Put the battle streamers into any type of case for transport
- 5 Lay the battle streamers down in the vehicle
- 6. Put the battle streamers on the flag on if there is a chance of rain/snow/high winds (outside use of the Department flag).

#### <u>Do</u>:

- Hang the metal ring holding the battle streamers on the Department hanger and hang it up in your vehicle when transporting the flag to events.
- 2. Hang the metal ring holding the battle streamers on the Department hanger and hang it up in a closet when the Department flag is being stored in between events.
- 3. Only if needed, periodically iron wrinkled battle streamers (use a protective cloth over the streamer and use light heat).

I purchased a ring for streamers for our Camp flag at paradestore.com for \$29.95 plus S&H.

Brother Daniel Grable gave a short explanation of the Grand Army of the Republic and the reason for the Sons of Union Veterans of the Civil War. He also introduced his fellow presenters. Commander Richard Scott started out by comparing the bloodiest day in the Civil War which occurred 150 years ago in 1863 at Antietam on the same date as the camp's school. Clifford Owen covered the causes and the legal compromises from the time of President Andrew Jackson and Vice President John C. Calhoun to the firing on Fort Sumter.

Then we entertained the students by having Donald Ogden showing a few items from his Civil War collection. He started out by showing the two major flags of the Confederacy - the National Stars and Bars and the famous Confederate battle flag of the crossed bars of stars. He showed a sample confederate uniform and a sample Union uniform and mentioning the emblems representing the branch of the army found on the kepi. This he followed by showing some real Confederate money and a Confederate War Bond. He ended his presentation by showing some personal Union items such as a tin cup and plate, a knife fork and spoon kit, a collapsible cup, a shaving kit, a housewife kit, a deck of cards, and a New Testament. The Camp's presentation was ended by Brother Owen talking about the number and causes of the casualties during the Civil War.

On Memorial Day weekend this year Grable attended the Memorial Worship service sponsored by the Grand Haven Memorial Day Association. It was held at the First Reformed Church in Grand Haven on Memorial Sunday Evening. Rev. John Kenny of the church, a veteran military Chaplin, preached on "The Responsibility of Freedom" based on 1 Peter 2:16. Rev. Kenny explained the rights of Peter's and Jesus' freedom and how it applies to our country.

On Memorial Day the camp participated in the Spring Lake Parade and Ceremonies. The Camp was the Honor Guard for the day. We marched at the front of the parade carryng our National and Camp flags behind the local police car and the American Legion Riders motor cycle group. The parade went from downtown Spring Lake to the Spring Lake cemetery north of the village.

During the ceremonies coordinated by the Spring Lake Heritage Festival Committee at the Spring Lake Cemetery the camp posted the camp's flags on the speaker's platform following the welcoming and introducing of the Grand Marshall Robert Twa. Later Camp Asst. Chaplin John Baldus read GAR Commander-in-Chief Gen. Logan's order #11 which started Memorial Day in 1868. Then Grable officially placed the memorial wreath on the speaker's platform in honor of the deceased veterans

Following the reading of the list of the local veterans who died during the last year the camp's Honor Guard of Baldus, Donald Ogden, Jonathan Scott and commander Scott fired the gun salute. This was followed with taps played by trumpeters from the Spring Lake High School Marching Band.

Grable then raised the Cemetery's American and POW flags from half-mast to full mast.

After the ceremonies the camp held their annual Anniversary Picnic for our brothers and their family members. It was held in the nearby Central Park We had seven brothers and family members who enjoyed our good food and camaraderie.

Also we had members of our Camp participating in other local ceremonies. In Fruitport PCC Max Riekse (Past Commander of Fruitport VFW Polar Bear Post 3734) and Jr. Member of our camp and Cub Scout Richard Riekse participated in the Fruitport Old Fashioned Days Memorial Day Parade.

In the Whitehall area local Brother Irvin Holgreve participated in the local Memorial Day ceremonies.

In June and July the Henry E. Plant Camp #3 will be very busy. In June the camp will be conducting a presentation during the Spring Lake Heritage Festival on the 150th Anniversary of the Battle of Gettysburg and its local connections with veterans from the Northwest Ottawa County area, Camp Brothers ancestors that fought in the Battle of Gettysburg, and memories of our brothers that appeared as re-enactors in Ted Turner's film entitled "Gettysburg".

In July the camp will participate in the City of Ferrysburg's Fourth of July Parade. The camp will have four uniformed brothers participating in a program conducted by the Tri-Cities Historical Museum and the Louitt District Library (of Grand Haven). We will also be holding our July Camp Meeting in the City of Holland.

This May our camp celebrated the 20th Anniversary of the formation and initiation of our camp. We were initiated into existence by the then Department of Michigan Commander James Pahl who would later become Commander-in-Chief of the SUVCW . Pahl was assisted by PDC Keith Harrison who would also become Commander-in-Chief of the SUVCW and MOLLUS and James T. Lyons who served as the first ever Executive Director of the Sons of Union Veterans of the Civil War. Also involved in our initiation were two Brothers who would become future Department of Michigan Commanders. They were J. Douglas Park and PDC Gary L. Gibson. We currently still have two of our original eight Charter members active in our camp. The Charter Members still active in our camp are John C. Baldus and Max J. Riekse. We also had one Charter Member Paul M.MacDonald who was very active in our camp until he departed in January 2010.

## Gov. Crapo Camp 145 Submitted by David Wallace, PCC



The Brothers of the Gov. Crapo Camp responded to a request for assistance to purchase flags for 300 Civil War veterans' graves in historic Glenwood Cemetery in Flint. A donation was made by the Camp in memory of Brother Rick Greene, PDC, who passed away earlier in May. "We felt it was a fitting tribute to Rick to be able to assist in 'Keeping Green the Memory'," commented Camp Commander Dean Lamphere. Glenwood Cemetery was established in 1857, two years after Flint became a city. Glenwood Cemetery was listed on the Michigan State Register of Historic Places in 1988 and the National Register of Historic Places in 2010. Several prominent Civil War veterans are buried there, including BG William Hawley, 3<sup>rd</sup> Wisconsin Volunteer Infantry, Col. William Fenton, 8<sup>th</sup> Michigan Infantry, Col. T.W.B. Stockton, 16<sup>th</sup> Michigan Infantry, and Col. William McCreery, 21<sup>st</sup> Michigan Infantry. All were Comrades of the Gov. Crapo Post No. 145 of Flint. Henry H. Crapo, 14th Michigan Governor (1865-1868) is buried in Glenwood Cemetery. LTC George Deas, CSA, Inspector General and staff officer with Robert E. Lee and Samuel Cooper, is also buried in Glenwood. He was the brother-in-law of Gen. James Longstreet, CSA. Longstreet was a nephew of Col. Stockton and a frequent post war visitor to Flint. The photo shows the oldest Civil War memorial in Flint, dedicated in 1866 to the memory of the soldiers who did not return. The GAR flag holder was placed by the Gov. Crapo Post No. 145 of Flint. PDC Greene would be pleased.

The Brothers of the Gov. Crapo Camp No. 145 of Flint concluded a busy week of ceremonies in Columbiaville and Flushing with a May 30<sup>th</sup> Memorial Day Ceremony at Aventine Cemetery in Flint. Also participating were members of the Lt. Edwin Terry Carrington Chapter of the National Society Daughters of the Union 1861 – 1865, and the Junior ROTC Color Guard from Flint Northwestern High School. Commander Dean Lamphere conducted the ceremony including a reading of General Orders No. 11 (Series 1868) and General Orders No. 15 (Series 1882). At the conclusion of the ceremony, the participants placed flowers on all veterans' graves. Aventine Cemetery has been a special project of the Gov. Crapo Camp since the Camp was chartered in 1992.

Abandoned in 1959 when its trust fund was depleted, several volunteer groups have helped maintain Aventine Cemetery. The Gov. Crapo Camp has been a



spearhead in organizing maintenance since 1993. The Camp has also investigated, documented and obtained headstones for many unmarked veterans' graves under the supervision of Graves Registration Officer, Matt Adair. Pictured in the photo, Camp members PDC Don Shaw, Neal Zabicki, Commander Dean Lamphere, Lloyd Lamphere and Gene Taylor review their cemetery maps to ensure all veterans' graves have been marked with a flag for Memorial Day.

## **Graves Registration Committee**

Your Department Graves Registration Committee met on June 8 at the State Archives. Attending that meeting were members Chris Czopek – At Large, Dick Williams – Camp 58, Dick Hutchins – Camp 120, Gary Copenhaver – Camp 17, Jim Petrimoulx – Camp 67, Charles Waters – Camp 7, Tom Bruce – Camp 20, and myself for Camp 427. Our database now has 62,046 Civil War burials and 3,456 Other War records. We discussed the current VA direction on ordering headstones, and concurred that the ruling would probably not be rescinded, so now what?

We re-hashed the ideas of 1) Creating a low-cost design (maybe home-made) for a "temporary marker" so that if we cannot find a descendent, we can manufacture and perhaps get a plastic attachment that states the man's name and regiment; and 2) at the suggestion of George Wilkinson, a 4<sup>th</sup> Michigan Infantry historian, we will partner with Alan Teelander, who has offered his Faded Footsteps site to list known burials of soldiers who do not have grave markers, and ask the public for a descendent to step forward aiding our task in marking the grave (we will also try and list these man on Find a Grave for the same purpose). If anyone has an idea about a "temporary grave marker" or resources for the same, let me know. A recent article by Katheryn Jorgensen in the May 2013 Civil War News states that "Steve L. Munro, Under Secretary for Memorial Affairs (VA) told the House Veterans Affairs on April 10 that current Code of Federal Regulations (CFR 38.632) – Headstone and Marker Application Process – appeared to be too restrictive. He said his agency is willing to do some rewrites and make it 'more user friendly'." These comments were prompted by New jersey Congressman Jon Runyan and were prompted by the Department of Ohio SUVCW. More to come.

We have many headstone dedications scheduled for the summer – attend as many as you can to honor our passed heros.
